4. Other Terms and Conditions applicable will be as follows:-
 1. The period of contract shall be 3 years from the date of agreement.
 2. Vehicle Tax, Insurance, Fuel, Oil, Driver's salary and maintenance charges shall be borne by the owner.

3. In case of non-availability of cash van an amount of Rs.1500/- per day will be deducted.
4. The Agency should have security clearance by State Govt.
5. The antecedents of the driver shall be got verified by the Police Authorities and copy of the same be kept on record alongwith copies of Driver's licence, Insurance cover of the vehicle duly attested by the Agency.
6. The vehicle shall be modeified by the Agency as per the Bank's Security norms and RBI specifications for Cash Van including arrangements for chaining the cash box to the body of the vehicle and arrangements for locking the door from inside(within).
7. The agreement shall be got verified/approved by Legal Cell of our Region.
8. The Cash Van shall be under the overall control of RO:Patna.
9. The vehicles should be equipped with Mobile phone connectivity.
10. The copy of the agreement , Kilometers run at the time of taking into Bank's services, RC Copies, model No. shall be provided to us.
11. GPS/GPRS shall be installed in the Van by vendors.
