

ANNEXURE I

FLOOD RELIEF LOAN SCHEME TO STAFF PENSIONERS OF THE SYNDICATE BANK

Eligibility: All Staff Pensioners who have suffered loss / damage to house hold goods / property due to recent flood in the State of Kerala & Kodagu district in Karnataka

Quantum: The quantum of loan shall not be more 3 months' Pension or loss / damage declared by the Pensioner whichever is less.

Repayment: The loan shall be repayable in 36 EMIs .Repayment shall commence from the succeeding month after disbursement.

Cut Back: Total cut back from pension shall not exceed 60% of the Pension including the proposed loan installment.

Rate of Interest: ONE YEAR MCLR

Guarantor: The family member who is eligible to receive family pension shall join the transaction as guarantor. In the case of family pensioners or where there is no eligible person to receive pension, third party guarantor with sufficient income/net worth shall join the transaction as guarantor.

Other conditions:

- a) The loan shall be extended based on self declaration of particulars of damage to the property / loss of house hold belongings by the affected staff pensioner residing in the area affected by the flood.
- b) The affected area is the one which has been declared so by the State Government.
- c) The affected staff pensioners who have availed the relief loans in the earlier years will also eligible for further relief loan under this natural calamity subject to the closure of the relief loan availed earlier. There shall **not be more than one** Flood Relief Loan outstanding of each employee at any given time.
- d) This facility of flood relief loan shall be availed by the affected retired staff pensioner on or before **31.12.2018** (which is cut-off date)
