SUB: REIMBURSEMENT OF IBA HEALTH INSURANCE PREMIUM UPTO ₹ 2500/- PER YEAR TO RETIREES – EXTENSION OF LAST DATE FOR SUBMISSION OF CLAIMS

Reimbursement of IBA Health Insurance / Synd Arogya premium and Annual Medical Expenses to the eligible retirees **was enabled in Synd HR with effect from 01/01/2020.**

Reimbursement up to ₹2500/- (Rupees two thousand five hundred only) per year to the retirees/spouse of the retirees of the Bank is payable who pay the premium for health insurance cover either under Synd Arogya Scheme OR IBA Health Insurance Scheme of the Bank. **Such reimbursement is restricted to ONE Scheme Only. The eligible retirees shall submit premium receipt of Synd Arogya Policy to the respective branch within 60 days of paying the premium.** The branch shall enter the details in Synd HR and will generate a printout of the application. Once the entry is authorized, the eligible amount will be credited to the respective account of the retiree. Likewise, for claims under IBA Group Health Insurance Policy for Retirees, a copy of the SB pass book showing premium remittance towards IBA Policy shall be submitted to the branch which will generate a printout of the application after entering the details in Synd HR. The eligible amount will be credited to the respective account of the retiree once the entry is authorised. The claim shall be made in the same financial year itself and there is no provision to carryover the claim for the subsequent year for whatsoever reason.

The claim should be made at the pension drawing Branch. In the case non pensioners, the claim may be made at the Branch where they are having the operative SB account and once the option of the Branch is given, it should not be changed and every year the claim shall be made at the same branch.

We have been receiving representations from various Retirees and their Associations to consider extension of the last date for submitting their claim as many of them were not aware of the claim/enhancement due to various reasons. As such, we are pleased to inform that the last date for submission of claims for reimbursement of **IBA Health Insurance only stands extended up to 15.03.2020.**
