IMPLEMENTATION OF HON'BLE SUPREME COURT OF INDIA JUDGEMENT ON PROVIDING BENEFIT OF ADDITIONAL NOTIONAL SERVICE UNDER REGULATION No 26 OF SYNDICATE BANK EMPLOYEES' PENSION REGULATIONS, 1995.—**ADDENDUM to Cir 379/2018/BC dt 27.09.2018.**

I. Background:

Attention of Branches/Offices is drawn to Circular No. 379-2018-BC-HRD-82-SWD dt 27.09.2018 wherein providing benefit of Additional Notional Service under Regulation 26 of Syndicate Bank Employees' Pension Regulation (SBEPR) 1995 was communicated. An employee shall be eligible to add to his service qualifying for superannuation pension (but not any other class of pension) the actual period not exceeding one fourth of the length of his service or actual period by which his age at the time of recruitment exceeded the upper age limit specified by the Bank for direct recruitment or a period of five years, whichever is less.

II. Current Reference:

We have issued Cir. No 379-2018-BC-HRD-82-SWD dated 27.09.2018 calling for applications for extending benefit of Additional Notional Service under Reg 26 of SBEPR 1995 in respect of Specialist Officers appointed by the Bank. In terms of Hon'ble Supreme Court of India Judgement and as per IBA guidelines, Reg 26 of SBEPR, 1995 provides Addition to qualifying service for officers appointed under specialist category. The eligible officers were informed to send their claims through their pension drawing branch. Pension was re-fixed and arrears were paid in eligible cases.

A few more specialist officers have submitted their claims now. The officers who are pensioners and those who are otherwise eligible under the above regulation shall submit their claims/ representation from pension drawing branch with all relative proof of documentary evidence for claiming eligibility as per Cir 379/2018/BC immediately.

The last date for submission of claims for benefit of Additional Notional Service under Reg 26 of SBEPR 1995 in respect of Specialist Officers will be 26.08.2019. Applications received after 26.08.2019 will NOT be entertained as sufficient time for submission of claims was already extended.

All other terms and conditions enumerated in Cir 379-2018-BC-HRD-82-SWD dated 27.09.2018 remain unchanged.
